Bhopal, the 11<sup>th</sup> December 2000 No. F.16-84-98-LV-ME-2.-In exercise of the powers conferred by clauses (k), (1), (o) and (q) of sub-section (2) of Section 51 read with Sections 21,22,26 and 48 of the Madhya Pradesh Homoeopathy Council Adhiniyam, 1976(No. 19 of 1976), the State Government repeals the Madhya Pradesh Homoeopathy Council(publication of Register and Appeal) Rules. 1976 and all amendment made thereafter and hereby substitutes the following rules, namely:--

#### **RULES**

#### Chapter I—Preliminary

- 1. **Short title**.--- These rules may be called the Madhya Pradesh Homoeopathy Council (Publication of Register and Appeal) Rules, 2000.
  - 2. **Definitions**. ---In these rules, unless the context otherwise requires,---
    - (a) "Adhiniyam" means the Madhya Pradesh Homoeopathy Council Adhiniyam, 1979 (No. 19 of 1976);
    - (b) "Appendix" means the Appendix appended to these rules;
    - (c) "From means the forms appended to these rules;
    - (d) "Section" means a Section of the Act;
    - (e) "Schedule" means the schedule appended to the Adhiniyam and Homoeopathy Central Council Act, 1973;
    - (f) "Year" means a calendar year.

#### Chapter II---Registration

- 3. **State Registers of Homoeopathy.---** The Registers under Section 21 shall be maintained in from "A" "B" and "c".
- (1) The Register for sub-section (1) of Section 22 shall be in from "A" for persons who possess qualification mentioned in the Schedule of Adhiniyam.
- (2) The Register for sub-section (2) of Section 22 Shall be in from "B" for persons who were enrolled under Section 16 (2) of the Madhya Pradesh Homoeopathic and Biochemic Practitioners Act. 1951 repealed by the Madhya Pradesh Homoeopathy Parishad Adhiniyam, 1976 and who were entered in the register maintained under rules 3(1) of the Madhya Pradesh Homoeopathy Council (Publication of Register and Appeal) Rules, 1976.
- (3) The Register for Section 24 shall be in From "C" for persons required to undergo for training for a period specified in the recognised courses to pass the qualifying examination.
- (4) The persons entered in the register maintained under the Madhya Pradesh Homoeopathy Council (Publication of Register and Appeal) Rules, 1976 shall be allotted new registration numbers in the sequential order in respective registers in From "A" and "B" and certificate of Registration in From "D" shall be issued.
  - (5) Each page of the Register shall be verified and signed by the Registrar.
- 4. **Verification and Renewal.** --- (1) The Registrar shall verify the State Register of Homoeopathy after every five years and shall intimate for renewal to all such practitioners enrolled earlier than one year from the date of publication of these rules under section 22 of the Act, through a notification in at least two State News papers, and send a letter of intimation along with an application in From "E".
- (2) Every person, within one year or on any other date fixed by the Council for the first time after publication of these rules and within 180 days from the expiry of five years of renewal, shall apply in from "E" along with his certificate of registration, and pay the fee as specified in the Appendix.
  - (3) The Registration fee and other fees payable under these rules shall be such as specified in the Appendix.

- (4) Every registration certificate renewed. Shall be endorsed and its corresponding entry shall be made in the Sate Register of Homoeopathy, which shall be attested and signed by the Registrar. After verification of the entry, the certificate in form "D" shall be sent to the persons cancelled through registered post.
- (5) if any person fails to apply along with the fee as specified in the Appendix in accordance with sub-rule (2) his registration under section 22 of the Adhiniyam. Shall be cancelled. He may apply for restoration of his name in from "F" after paying the fee as specified in the Appendix.
  - 5. **Publication of the Register.---**(1) the Registrar shall revise the register every five year and enter therein :---
    - (a) the number of practitioners already registered.
  - (b) The number of practitioners registered during the period of five years preceding the revision of the Register;
  - (c) the number of practitioner whose names have been removed from the register during the period of five years preceding the revision of the Register stating the sub-section of the Adhiniyam under which the names have been removed:
  - (d) the number of practitioner whose names have been restored to the register during the period of five years preceding the revision of the register: and
  - (e) the number of practitioner whose names have been removed by reason of death during the period of five years preceding the revision of the Register.
- (2) The revised register shall be published in the Madhya Pradesh Gazette within 180 days after completion of the period of five year preceding the revision of the register and registered practitioners adversely affected by the revision shall be informed of the adverse effects on them, by registered post.
- (3) A copy of the register in accordance with rule 3 or the revised register, as the case may be, so published, shall be affixed on the notice-board of the Council.
  - (4) Printed copies of the register may be made available for sale at a price to be decided by the council.
  - (5) The register shall verify and authenticate all entries that may be made, altered or erased during each year.
- 6. **Application and fees for Registration.** --- The application for entry under sub-section (1) of Section 22 shall be in From "F" and shall be accompanied by a receipt of payment of fee as specified in the appendix, and a true copy of certificate of recognised qualification duly attested by a Magistrate or a Gazetted Officer. The applicant may also enclosed copies of such certificates and documents in support of his application. The Registrar may require the applicant to furnish nay other certificate/document in original for verification.
- 7. **Provisional Registration.**—(1) No candidate after passing the qualifying examination shall be allowed to undergo training unless he has applied in from "G" through the principal of the recognised institution in which the applicant has been asked to undergo training and paid the fees for provisional registration.
- (2) The Provisional Registration granted under section 24 of the Adhiniyam shall remain in force for a period no exceeding 6 months from the date on which the Council/University awarded diploma/degree to the successful candidate.
- (3) The practitioner who has been granted the provisional registration in From "H" after completion of training shall obtain his diploma/degree and submit its copy duly attested to the Registrar within 6 month the fixed under subrule (2) for registration under Section 22 of the Adhiniyam.
- (4) If any person fails to apply under sub-rule (3) within the time prescribed therein, he shall cease to be registered under clause (a) or (b) of Section 24 of the Adhiniyam and his name shall be removed from the State Register. On application for re-registration of his name, he shall be to pay late fee as specified in Appendix.

- 8. **Addition of qualification.** ---Any person who intimate to enter any additional qualification against his name may make an application along with the certificate and shall pay the fee as specified in the Appendix.
- 9. **Duplicate copy of Registration.** ---An application for a duplicate copy of registration certificate shall be submitted to the Registrar accompanied by an affidavit showing cause for obtaining the duplicate copy and shall pay the fee as specified in the Appendix.
- 10. **Change of name or surname**. ---Any practitioner willing to change his/her name or surname or address shall make an application along with proof for such change to the register, and shall pay the fee as specified in the Appendix. The Registrar shall change the entry and inform the applicant in writing.
- 11. **Certificate of registration.** --- The certificate of registration under sub-section (3) of Section 22 shall be in From "D" and the provisional certificate of registration under Section 24 shall be in from "H"
- 12. **Verification from outside State.** ---Any person who holds recognised qualification from the State other than Madhya Pradesh, if applied for registration to the Council. Shall be liable to play the prescribed fee for verification. If the Council is asked for verification from other Council/Board for granting registration, the Registrar shall verify such cases after receipt of the fee as specified in the Appendix.
- 13. **Manner of payment of fee**. ---The fee required to be paid under these rules may be paid in cash/money order or through Bank Draft payable to the register.

#### **Chapter III---Appeals**

- 14. **Memorandum of Appeal**. ---(1) Every appeal under Section 48 of the Adhiniyam shall.
  - (a) be filed within forty five days from the date of communication of the order against which the appeal is to be filed;
  - (b) be accompanied by a satisfactory proof of payment of a fee specified in the Appendix;
  - (c) apply in writing;
  - (d) specify the name and address of the appellant;
  - (e) specify the date of the order against which the appeal is to be filed;
  - (f) specify the date on which the order was communicated to the appellant;
  - (g) enclosed a statement of facts;
  - (h) state precisely the relief prayed for k and;
  - (i) be signed and verified by the appellant or an agent duly authorized by him in writing in writing in this behalf in the following from, namely:---

- (2) The memorandum of appeal shall be accompanied by an authenticated copy of the order against which the appeal is preferred, unless the appellant satisfies the appellate authority at the time of presentation of the appeal that there is sufficient cause for omission in such case it shall be filed within such time as may be fixed by the said authority.
- (3) The memorandum of appeal shall be in duplicate and shall be presented to the appellate authority either by the appellant or his agent or sent to said authority by registered post. When an appeal is presented by an agent duly authorized by the appellant or it shall be accompanied by a duly stamped letter of authority appointing him as such.
- 15. **Summary rejection of appeal**. ---(1) If the memorandum of appeal does not comply with all or any of the requirements of rule 14. The appeal may be summarily rejected;

Provided that no appeal shall be summarily rejected under this sub-rule unless the appellant is given such opportunity as the appellate authority thinks fit to amend such memorandum of appeal so as to bring it into conformity with the requirements of the rule.

(2) An appeal may also be summarily rejected on any other grounds which shall be reduced to writing by the appellant authority:

Provided that before an order summarily rejecting an appeal under this sub-rule is passed, the appellant shall be given a reasonable opportunity of being heard.

- 16. **Hearing of appeal**.---(1) If the appellant authority dose not reject the appeal summarily, it shall fix a date for hearing the appellant or his duly authorized agent.
  - (2) The said authority may at any stage adjourn the hearing of an appeal to any other date.
- (3) If on the date fixed for hearing or any other date to which the hearing is adjourned, the appellant does not appear before the said authority ether in persons or though an agent duly authorised by the appellant, the said authority may dismiss the appeal or may decide it exparte as it thinks fit.
- (4) When an appeal is dismissed or decided exparte under sub-rule (3), the appellant may within 60 days from the date of communication of such order apply to the appellate authority for re-admission or re-hearing of the appeal and if the appellate authority is satisfied that the appellant or an agent duly authorized was prevented by sufficient cause from as to cost and condition as it may think fit.
- 17. **Supply of copy of order passed in appeal**. --- A copy of the order passed in appeal shall be supplied free of cost to the appellant and another copy shall be sent to the officer whose order forms the subject matter of the appeal.
  - 18. The Council, if required, may make correction in the forms appended to these rules.
- 19. **Repeal and saving.---** All rules corresponding to these rules in force immediately before the commencement of these rules are hereby repealed:

Provided that any application for registration either u/s 22 or 24 is complete and fee deposited but pending for grant of registration under the rules so repealed shall be deemed to have made under the corresponding provisions of these rules.
