समस्त होम्योपैथिक चिकित्सक संगठनों, चिकित्सकों, शिक्षकों एवं छात्रों को सूचित किया जाता है कि राष्ट्रीय होम्योपैथी आयोग, नई दिल्ली द्वारा "राष्ट्रीय होम्योपैथी आयोग (होम्योपैथी चिकित्सकों के लिए राष्ट्रीय रजिस्टर तैयार करने और रख-रखाव का तरीका) विनियम 2022" और "राष्ट्रीय होम्योपैथी आयोग (होम्योपैथी चिकित्सकों के लिए व्यावसायिक आचरण, शिष्टाचार और आचार संहिता) विनियम 2022" में संशोधन हेतु संलग्न प्रारूप (ड्रॉफ्ट) में सर्व संबंधितों से विचार एवं सुझाव आमंत्रित किया गया है। आयोग के संशोधन प्रारूप में होम्योपैथिक चिकित्सकों के प्रत्येक 05 वर्ष में पंजीयन पुनरीक्षण हेतु CME's (Continuing Medical Education) के माध्यम से 100 Credit Point अर्जित करने की भी व्यवस्था प्रस्तावित की गयी है।



Proposed CMEs Guideline for Updation of Registration

1. CMEs shall be conducted physical as well as virtual under the aegis of Homoeopathic Medical College / Research Institute / reputed organisation / registered homoeopathic practitioners associations etc, which possess the essential technical infrastructure and IT support to implement the Programme without technical glitches, with the prior permission from BERH-NCH.
2. It will be responsibility of State Councils / boards, to plan enough CMEs, which provide each practitioner to attend at least **two CMEs in five years** (for 100 credit points in Up-dation interval) considering the number of practitioners registered in the concerned state.
3. The State Board / Council must inform to BERH the details of CME before conducting, at least two weeks in advance. The tentative CMEs schedule for every year may be planned in beginning of year.
4. All the registered practitioners may be informed proposed CMEs schedule for every year as may be planned tentative in beginning of year by the state councils/boards.
5. The participants may be informed about the details of the specific programme, necessity of the programme along with the topic, to enable them to register online well in advance by the organisers.
6. The conducting organization must ensure that the speakers shall be of National / International repute and well familiar with the latest development and research in the field of medical science and preferably possessing PG qualification in Homoeopathy or in Modern Medicine or in the related field.
7. Streaming type of the Webinar/ CME may be: -
 - a. Social media: YouTube, Zoom, Facebook live, Amazon web services or other similar online platforms.
 - b. Classroom type: Google meet, Zoom, Cisco Webex or other similar online platforms.
 - c. Training modules: Pre-recorded lectures followed by evaluation (preferable MCQ based)
 - d. For such webinars the system of online MCQ and interactive session for verification of thorough participation shall be compulsory.
8. All sessions must be recorded and archived permanently in soft copy with the concerned State council / boards and shall be made available to the BERH by email within 15 days.
9. Periodic time stamped screenshots must be taken preferable showing the number

of attending delegates. (at start, half an hour of start, in every slot of 1 hour, at the end of CMEs).

10. After the CMEs, feedback of the participants shall be taken to assess the quality and for improvement in future. The feedback response documents must be submitted to BERH within 15 days: the Day wise excel sheet of Names, Mobile No. and Registration Number of attending doctors, periodic time with stamped screenshots.
11. Advertisement of any product/drug/Hospital/Clinic/Independent practitioner during the session and in the screening, shall be strictly prohibited. There should not be conflict of interest and criticisms of other practice or system of medicine in any portion of CMEs.
12. BERH, NCH may appoint an observer to verify the conduct and progress of CMEs. He/ she can verify the attendance of delegates. BERH must be provided with the link to attend the CMEs at least one week in advance. Observer shall submit report within 3 days to President, BERH. Concerned State Board / Council shall pay fee of Rs.2000/- along with existing TA/DA as per central government norms to the external Observer, if not working on the role of the NCH.
13. State Board / Council should issue to the delegate the certificate only on the last hour at the closure of CMEs. Certificates should not be distributed on the first day at the time of registration for the physical or virtual CMEs. This certificate shall be submitted to the State Board / Council at the time of renewal or updation of registration for the credit points.
14. There shall be minimum two sessions during the day with not less than three hours duration of each session with an hour break in between for the full credit points. State Board / Council may charge fee of not more than Rs.2000/- per CME per day from the delegates and shall pay remuneration not more than Rs.3000/- per session (Three hours) to the Experts and not more than Rs.50,000/- per day to the institution providing infrastructure for the programme.
15. At least two CMEs (50 credit points each) of not less than six hours duration, must be attended by each registered doctor within five years before getting his / her registration renewed/ updated with the State Board / Council. Among that, 50 credit point is compulsory from physical CMEs, during five years. This will be applicable for the doctors whose registration is due for renewal w.e.f. 01.01.2027 onwards.
16. The Practitioners who are of 70 years or more on the date of renewal or practitioners registered based on experience (Part B) are exempted from attending the CMEs.
17. The experts honoured as speakers of sessions under such recognized CMEs will be allowed 10 credit points for one session, up to maximum 10 credit points in one year and maximum 50 credit points during five years.


18. Practitioners must complete 100 credit points during five years and may avail maximum 50 credit points in one year.
19. Any organiser of CME shall take prior permission from BERH-NCH by an application forwarded through state board / council at least 30 days in advance with the details of speakers, subject, venue and program.
20. The credit points to of the CMEs by the State Homoeopathy Council / Board will only be consider as credit points for the practitioners registered / enrolled under the same authority. For the practitioners registered at NCH (Where state council is not constituted) shall be eligible to complete their all-credit points through virtual CMEs organised by NCH.
21. BERH-NCH may authorise the other agency to organise CMEs, if any state board/Council fails to conduct necessary numbers of CMEs.
